

ANCCE-LGPRESERVICE 619 - CHANGE OF OWNERSHIP IN THE SPANISH STUDBOOK, SPAIN.

When you buy a PRE horse in the UK you MUST register the Transfer the Ownership with the relevant PIO, BAPSH Ltd, within 30 days of the purchase, and this has been completed for your horse. Now you have done this transfer, we recommend that you proceed to apply for the Stage 2 non-compulsory Change of Ownership with the SPANISH STUDBOOK which will change your horse's records on the ANCCE-LGPRESERVICE online studbook. See how to do this below here:-

Stage 2 This Transfer is referred to as the LGPRE Service 619 Transfer and utilises the ANCCE CARTA DE TITULARIDAD that accompanies the horse's Passport. This second stage Transfer creates the Change of Ownership in the Spanish Studbook in Seville (ANCCE-LGPRESERVICE) which is the mother Studbook. The LGPRE Service 619 Transfer is **ESSENTIAL** for BAPSH Ltd registered PREs and New Imported PREs if they are **Breeding stock or Potential Breeding Stock**.

The LGPRE Service 619 Transfer is not a UK legal requirement but BAPSH Ltd recommends that the new owner does complete this second stage Transfer so that the Ownership recorded in the ANCCE-LGPRESERVICE matches the Ownership recorded by BAPSH Ltd and DEFRA.

NOTE:- The New Owner MUST have an LGPRE Breeder Code or LGPRE Owner Code in order to be able to apply for Services from the LGPRE. If you do not know what this is or are unsure whether you have an LGPRE Code then you should contact the BAPSH Ltd Registrar – bapshregistrar@btinternet.com .

i). Complete the back of the CARTA DE TITULARIDAD with:-

Your name and address,

Your ID number which will either be your own Passport number or your Driving Licence number,

Your LGPRE Breeder Code or your LGPRE Owner Code

Your signature within the **'El Comprador'** Box bottom right-hand corner - the **'El Vendedor'** Box should already be signed.

Your location and the date above the signature Boxes. *All details MUST match those already held by LGPRE*

NOTE: The signature in the **'El Vendedor'** Box MUST be that of the person named on the FRONT of the Carta.

If this Box is blank or someone else has signed this Box contact the Registrar immediately

If your horse has NEVER had a Carta de Titularidad issued to it (you can check this out with the Registrar or for yourself on www.lgancce.com – Consult Horses) then you MUST complete an ANCCE-LGPRESERVICE Declaration of Ownership form (download from www.bapsh.co.uk – Buying and Selling Horses - Change of Ownership) and also provide a scan or photocopy of **your own Passport or Driving Licence**. Send these two Documents to the Registrar instead of the non-existent Carta. Your horse will receive its FIRST Carta when the Service 619 is completed.

ii) **Download** the ANCCE-LGPRESERVICE International Service Application form from www.bapsh.co.uk – Buying and Selling Horses - Change of Ownership. Complete the ANCCE International Service application legibly with the same details as you have written on the back of the Carta.

The Service number is 619. The Fee is **£55.00 - inc P&P to Spain**.

The number of horses that can go on one form for the same type of Service is between 1 and 10.

Complete the Box **'Horses You Are Requesting Service For'** with your Horse's Passport (UELN)

Number/Code in column one and the full registered Name in column two.

iii) Fee - **£55.00** This can be paid by cheque made out to BAPSH Ltd, or by Bank Transfer. The Registry Account Bank details can be obtained from the Registrar – please email if required.

iv) Send the completed documents and fee to the BAPSH Ltd Registrar. Upon receipt, the Studbook Registrar will pay LGPRE, input the new owner's data into the Spanish Studbook, and send the Carta de Titularidad and ANCCE International Service application form to LGPRE in Spain. LGPRE will then create a new Carta de Titularidad in the new owners name and LGPRE Code and send it back to the BAPSH Ltd Studbook Registrar. It is usually 4 to 6 weeks before the new Carta is received in the BAPSH Ltd Registry office.

Finally the Carta de Titularidad will be sent to the new owner by the Registrar.
