1. Horse that have never had a Passport

- PARTBREDS & REGISTER IV - SEND your BAHS or BAPSH Registration Certificate for each horse with this Form
- Purebred Spanish Horses (PRE) - SEND your Cria Caballar Registration Certificate for each horse with this Form. These will be verified and returned with your New Passport
- Clearly State & Describe below any i) Change of Colour, ii) Change of Markings, iii) Aquired Brands, Freezemarks, & Scars, or iv) an unrecorded MICROCHIP insertion, that has occurred since original registration.

2. DUPLICATE PASSPORTS - You MUST use the special DUPLICATE PASSPORT APPLICATION form. You must also write a formal letter declaring the Original Passport Lost or Destroyed and the circumstances of its loss must accompany the Application for a Duplicate. ONLY the Owner registered in the BAPSH database may apply for a Duplicate.

3. New IMPORTS without Passports MUST apply for an IMPORT Registration with BAPSH Ltd at the same time as their new Passport application

4. FEES - New Passports = **£28.00** each, Duplicate Passports = **£78.00** each. Both fees include Recorded Delivery return P&P.

No Passports will be issued without FULL Payment. Cheques to be made payable to BAPSH Ltd.
